Regard given to the Local Development Plan

Our plan aligns also with the Scottish Borders Local Development Plan (LDP2) 2021-2026 (Adopted on 22/08/2024). LDP2 expresses commitment to digital connectivity and an improved transport infrastructure in line with our aspirations relating to connectivity. It also foregrounds sustainability/ net zero, the promotion of health and wellbeing and the protection of the natural and built environment, all of which are themes which run through our 7 community outcomes.

Regard given to the National Planning Framework

Our overall Vision (see p.5) relates to the aspiration of NPF4 to create 'sustainable, liveable and productive places' (foreword). Our theme of connectivity resonates with the commitment to digital connectivity and transport infrastructure. Its concern for 'Just Transition' (to net zero) resonates with our theme of sustainability whilst at the same time acknowledging that 'environmental quality is a key asset for rural areas', as identified in our section on the rural environment. Other outcomes within our plan relate to the commitment in NPF4 to local living, rural revitilisation, tourism, culture and creativity, as well as health and wellbeing.

The challenges acknowledged within NPF4 are those identified in our Community Led Plan including rural living consistent with climate change in areas with limited public

transport and high levels of wellbeing and quality of life but with populations with increasing numbers of older people and fewer young people. (South of Scotland Regional Priorities)

Regard given to the Locality Plan

The themes of the Berwickshire Locality Plan of economy, skills and learning; health, care and wellbeing; quality of life and environment and place are reflected within the themes of our Community Led Plan.

Reasons for amendments being sought to the Local Development Plan

The Spatial Strategy included in LDP2 focuses on 3 key areas and on the major town centres of the Scottish Borders. There is no consideration of how smaller places such as Leitholm, Eccles and Birgham might relate to this. Elsewhere, the plan recognizes the importance of improved connectivity for economic growth and yet transport infrastructure to link villages to towns seems to be lacking.

Therefore, the Local Development Plan needs to make explicit how the different aspects of the plan might work together and how smaller places and not just larger towns may benefit. Another example of this would be to look at how proposals such as our aspiration for footpaths and cycle paths linking the three villages could be incorporated as part of the Active Travel initiative. (outcome 7 Tourism and Heritage)

Community support for the Local Place Plan

The process of consultation and planning started at our meeting in Eccles on 10 August 2022. This plan reflects planning and progress since that date. The plan was created following an initial consultation with people residing in our area. A questionnaire was designed drawing on the themes of the Scottish Place Plan tool and delivered to every household in Spring 2023. The questionnaire had a 20 % response rate and the Community Led Plan was written to reflect the issues raised and the themes which emerged.

It is a living document which will be amended and updated in the light of further consultation and of changing contexts and priorities. Since the original questionnaire,

consultation on the draft plan has taken place through drop- in sessions or events such as coffee mornings or cheese and wine evenings which have generally been well attended. However, it is clear that not everyone attends social events and so the process of door- to -door consultation has taken place in Leitholm and Eccles and will shortly take place in Birgham. There has been extensive consultation with Birgham Community Development Trust, initially through a meeting exclusively on the topic of the Place Plan (06/09/2023) and thereafter as an agenda item at each monthly meeting. The Development Trust is in regular contact with the wider Birgham community and as such is aware of community needs and priorities. In Birgham, the Development Trust has additionally started the process of a questionnaire and community meeting regarding the future of the local pub. In addition, the Community Council intend to undertake consultation with those who live in the more outlying rural areas and with our young people. The latter consultation is ongoing with Kelso High School having already participated.

The governance and decision - making process is as follows – A small sub group comprised of four community councillors and representative of all three villages work on the plan, each taking responsibility for reporting back to and feeding in from their relevant village committee or group. In Leitholm this is the Village Hall Committee and in Birgham this is Birgham Community Development Trust's meeting of Trustees. In Eccles there is no such committee but the village is small and the two councillors are in regular touch with their community. The Community Led Plan Lead reports on progress to a full meeting of the Community Council every two months in addition to individual reports from each village and surrounding area.

Thank you for your comments regarding our Place Plan. We started the process about two years ago with some enthusiasm, consultations raised the profile of the work of our community council and we were clear that the plan would guide our work into the future. This said, it was only about 6 - 9 months ago that the Scottish Government provided the stipulations needed to ensure that the Plan could be registered with and would be recognised by the local authority. The complexity of the reporting procedure, for a community council is ridiculous. What started off as a Place Plan providing the priorities and aspirations of our community in about 8 pages is now a mammoth document over 50 pages. Were it not for the skills of Anne Wales and her small team, we would have given up on this months ago.

I am aware that community councils are entitled to ask for a consultant to help them with the process and to write their Place Plan, however, at around £20k per community council I personally feel that this is very poor use of tax payers money.

At this time we see our plan as being a living document, subject to change as priorities change. As yet, we have no idea how these changes will be fed into the registered plan.

The cognisance taken of our plan is yet to be seen.

Thank you for your remarks regarding our Place Plan.

Regarding Community Benefits I would advise that these are not in the same scale as those for Wind Turbines. At this time Zenobe have committed to providing £25k per year and have been clear that this must be spent within our Community council area as the area which is impacted by their operations.

It is interesting that your Community Council are now looking to work more closely with us as when we reached out to both Coldstream and Greenlaw Community Councils for support in opposing the proliferation of BESS in our area, neither made any commitment. At this time we are still battling to stop BESS developments in the planning process from ruining our rural landscape. The impact on our community has been profound for most and devastating for those on the periphery of proposed sites.

This said, we would be more than happy to meet with you to discuss areas of mutual interest.
