RESIDENTIAL PARKING PERMIT INFORMATION

The table below details information on our Resident Parking Permits. We currently have 3 types of permit: Resident Annual Permit for residents in the Scottish Borders priced at £26.00 (Inc VAT), Visitor Annual Permit priced at £41.50 (Inc VAT) and Resident Annual Permit specific to a local car park, namely High Street car park, Galashiels, priced at £60.00 (Inc VAT). Any surplus revenue from the wider Pay and Display regime can be spent by the local authority on local schemes and initiatives in that area. Local councillors determine the distribution of any surplus.
